VLP ENROLLED 229 VETERANS INTO ITS JOB TRAINING AND PLACEMENT PROGRAMS, PROVIDING FREE EMPLOYMENT SERVICES THAT INCLUDE RESUME ASSISTANCE, INTERVIEW TECHNIQUES, NETWORKING TRAINING, INDIVIDUALIZED JOB SEARCH PLANS, AND CAREER COUNSELING. 134 OF THESE CLIENTS WERE SUCCESSFULLY PLACED INTO POSITIONS OF UNSUBSIDIZED EMPLOYMENT.

VLP IS ONLY 1 OF ONLY 4 AGENCIES IN WESTERN PENNSYLVANIA THAT IS GRANTED TO SERVE VETERANS IN 18 COUNTIES. VLP ALSO OPERATES AN EMERGENCY HOUSING PROGRAM TO KEEP FAMILIES TOGETHER WHEN EXPERIENCING HOMELESSNESS WHICH PROVIDED SERVICES TO 176 VETERAN HOUSEHOLDS.
